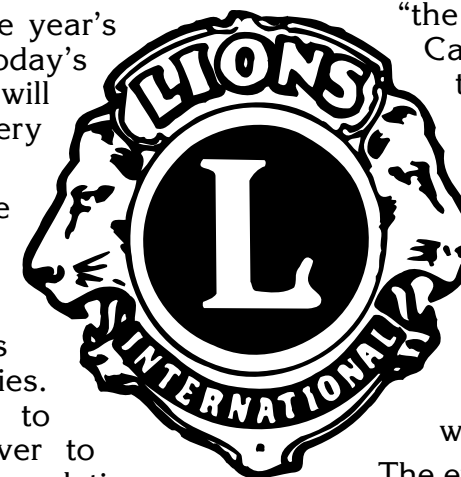

The Battle River Community Foundation is hosting its Annual Open House on Tuesday, May 26 at the Norsemen Inn.

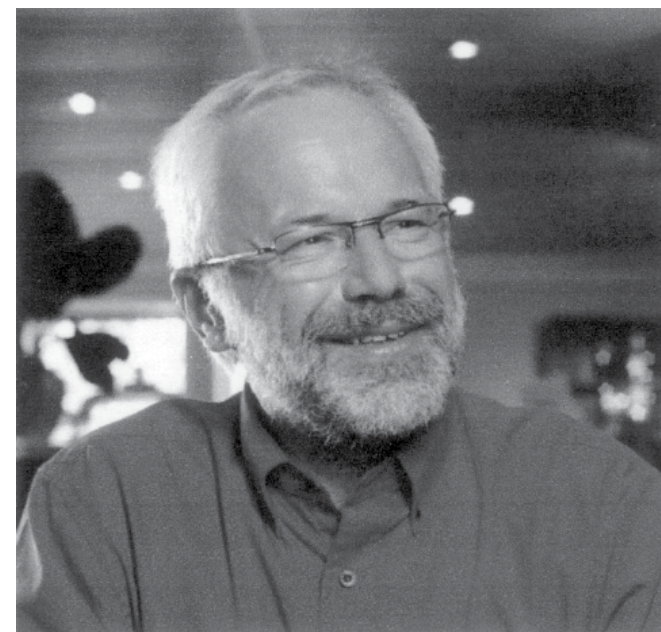
In addition to an update on the year's activities and a frank review of today's financial realities, the evening will include comments from two very special speakers.

Bidding farewell to Dave Stolee

After 14 years of exemplary service, Dave Stolee stepped down as Executive Director of the Battle River Community Foundation on March 31.

Mr. Stolee has been with the Foundation since its inception in 1995, when he was appointed to the very first Board of Directors. He served as Treasurer until 1998, when the organization had grown enough to hire a "very part time" staff person and he accepted the job.

In his role as Executive Director, Mr. Stolee says he has felt privileged to be part of the progress and growth of the Battle River Community Foundation. "We started, literally, with nothing," he recalls. "And we've grown into an organization that can make a real difference."

Mr. Stolee says he has enjoyed working with donors to the Foundation. "There are so many people who believe deeply in the philosophy of giving back. It's been very gratifying to meet those people and help them support the communities and projects that are important to them."

"In my time, we've given more than one million dollars back to the communities of the Battle River area," he says. "Big or small, every

donation has made a difference."

Battle River Community Foundation Board Chair Blain Fowler has true admiration for Dave Stolee and for the clear-headed and positive way in which he has provided guidance and behind-the-scenes support to the Foundation.

"We have been very fortunate to have Dave Stolee working with us in our first decade. He has been an exceptional staff member and we wish him all the best in whatever he chooses to do in the future."

Despite Mr. Stolee's long history with the Foundation, Mr. Fowler is confident in the future of the organization. "That's the beauty of an organization that is specifically set up to carry on for the long term and continue to meet the needs of the community," he explains. "We have policies and processes that make it possible for us to pick up and move forward, even as the people involved change."

Grants being presented

Representatives of the Battle River Community Foundation have been busy in recent months, visiting organizations and presenting grant cheques based on income from the 2008 year. Below is a small sample of the grants that have been given to organizations throughout east central Alberta.
